The Center on Addiction and Substance Abuse at Columbia University released a study that showed that in 1998 states spent \$81.3 billion on substance abuse, 13.1% of all state spending. Of each dollar spent by states, 96 cents went to shovel up the wreckage of substance abuse and addiction. Only 4 cents went toward prevention and treatment.

## **Effect of Insurance Parity on Substance Abuse Treatment**

The Paul Wellstone and Pete Domenici Mental Health Parity and Addiction Equity Act of 2008 (MHPAEA) is a federal law that generally prevents group health plans and health insurance issuers that provide mental health or substance use disorder (MH/SUD) benefits from imposing less favorable benefit limitations on those benefits than on medical/surgical benefits.
